# INSTITUTE OF COOPERATIVE MANAGEMENT

#### POOJAPPURA, THIRUVANANTHAPURAM

nstitute of Cooperative Management has been functioning as a unit of National Council for Cooperative Training (NCCT) New Delhi, an autonomous society promoted by Ministry of Cooperation, Government of India. The Institute. established on 19th October 1976, has been functioning with the objective of infusing professionalism in the Management of Cooperatives. The Institute caters to the training requirements of the Executives of Cooperative enterprises and the officers of Government Departments concerned with development of cooperatives.

The core activities of the Institute include: MDP, HDCM, Sectoral Diploma, MBA and Consultancy Service.

Management Development Programmes: The Institute conducts need based training programmes in different functional areas of management on topics such as Cooperative Law, Banking, Funds Management, Customer Service, Detection of fake currency, Gold Appraisal, Digital Banking, Taxation etc. As per the KCS Rule 185(1), for getting promotion and earning annual grade increment for employees in cooperatives, the Institute conducts Professional Development Programme (For Secretaries, Assistant Secretaries, Branch Managers, Chief Accountants, and Internal Auditors). Career Development Programme (for Accountants, Senior Clerks and Junior Clerks) and Skill Development Programme for sub staff of PACS, UCBs and other Societies. Every year Institute schedules 80 programmes with 2000 participants.

HDCM: Higher Diploma in Cooperative Management Programme (52 weeks) is the core programme of the Institute, which is recognized by the Govt. of Kerala as well as the Kerala PSC for employment in Cooperative Organizations and Departments.

Sectoral Diploma : Institute conducts 3 months Diploma programme for the officers and Cooperative Institution under union

functional Registrars. Usually the programmes are Diploma in Management of Dairy Cooperatives (DMDC), Diploma in Management of Industrial Cooperatives (DICM), Diploma in Cooperative Audit, Diploma in Management of Computer Operations (DMCO) etc.

MBA: Since 2003 the Institute has been conducting MBA programme as an extension centre of University of Kerala. The Institute provides extensive infrastructural facilities and gives more emphasis on building professionalism among the students

Consultancy Services: The Institute acts as a centre for providing consulting services to the cooperatives and departments for finding solutions to the various managerial issues faced by them.

Faculty: Institute has eminent and well experienced faculty members, and most of them are trained by Indian Institute of Management, Ahmedabad.

Library: The Institute has a fully computerized library with more than 15500 Books in the areas of Cooperation, Management in general and the functional areas of management in particular. It also subscribes regularly more than 100 National and International Journals and Periodicals. Apart from this, institute is maintaining a Digital Library also.

Computer Lab: We have an excellent computer lab with more than 30 systems connected by LAN, with high speed Broadband Internet and Wi-Fi facilities.

Video Conferencing: The Institute has a well-equipped Video Conferencing Room with a capacity to accommodate 12 – 15 participants at a time.

Audio Visual Aids: The Institute has Audio-Visual Aids such as Multimedia Projectors, in all the Training/Lecture Halls.

Hostel Facilities: Well-furnished hostel with mess facilities for both men & women with a total capacity of 120.
