

The webinar was designed to focus on two critical sub-themes:

- 1. Convergence, Value Creation, Scaling-up, Members' Awareness, Education and Training – this section had a lineup of five top-level cooperative sector officials from the Centre and the States
- 2. Tapping of Opportunities by Training Institutes in Skill and Entrepreneurship Development – this section had a lineup of five leaders of national-level institutions which are important stakeholders in the cooperative ecosystem.

Welcome Address and Opening Remarks by Shri Mohan Kumar Mishra, Secretary, National Council of Cooperative Training, Ministry of Cooperation, Government of India



Shri Mohan Kumar Mishra, Secretary, NCCT, welcomed all the distinguished speakers and participants and set the tone for the webinar by highlighting the importance of the day of the National webinar - the International Co-operative Day as an annual celebration of the cooperative movement that is observed on the first Saturday in July since 1923, by the International Co-operative Alliance. This year, the International Day of Cooperatives is being celebrated with a theme of "Cooperatives Build a Better World".

He introduced an array of distinguished speakers in the discussion. He especially acknowledged Dr Umakant Dash, Director, IRMA, Anand, a public policy expert who has had vast experience in the area of research and has had long collaborations with international organizations like WHO and DFID. He welcomed and thanked Shri Alok Agarwal, Joint Secretary (CET) Ministry of Cooperation as the mentor, friend, philosopher and guide to NCCT. He appreciated sectoral representatives, who are the leaders in the cooperative sector and have led their cooperative institutions effectively and successful.

### Keynote Address Keynote Address by Dr. Neelam Patel, Sr. Advisor, NITI Aayog



Dr. Neelam Patel, in a recognition of the year's theme, highlighted that the cooperatives all over have made a unique contribution in building a better world. There are various success stories throughout the world which showcase the importance of cooperatives in various sectors of the economy. The following are the major learnings from cooperatives:

- > They foster economic participation.
- > They contribute to food security.
- > They fight against environmental issues and climate change.
- Through cooperatives, we can keep the capital within the local community and help the condition of people and enhance their livelihood.
- India is the largest producer of milk and almost 2 lac milk cooperatives exist in the country, a transformation which began with Gujarat and has spread through the cooperative sector to many other states.
- Today in India, almost 85% of the farmers are small and marginal; these farmers need support in the form of good quality inputs, small amounts of credit and other services, including information. It is observed that farmers with higher information have 12% more returns per hectare than those who do not possess such information.
- The idea should revolve around adopting best practices and replicating them wherever possible. The 10000 FPO scheme also brings together farmers and is an initiative to create farmers' collectives.
- Lastly, start-ups should be given handholding support and training through cooperatives.

# Shri Alok Agarwal, Joint Secretary (CET), Ministry of Cooperation, Government of India



According to Shri Alok Agarwal, the most important aspect for any sector to boom is persistence and consistent efforts. He made the following key points:

- The focus has always been on small pockets, with limited means and whatever training institutes that have been in operation for the last few decades.
- > Now, the time has come to look beyond the obvious.
- We need to look at new alternatives and new ways to reach out to people and provide them training.
- We need to adopt new age technologies through television channel or online learning or through the university that is being talked about in each state.
- In terms of quality, curriculum, we need to focus on the need of the industry. For example, a chiller plant, we need people who can be trained to run it.
- At this point of time, the main focus of the Ministry of Cooperation is on reviving the training structure Pan India basis.

# Shri G Srinivasa Rao, Additional Registrar of Cooperative Societies, Telangana



Shri G Srinivasa Rao briefly discussed his experiences of best practices of Telangana:

- Training of the human resources is the most important aspect in an organization, and for the cooperatives particularly, it is the need of the hour. We need to compete with the corporate sector which has always invested a lot in training and education.
- > The problem with the training currently being imparted is relevance.
- We need to ask if the training is interesting or not, whether there is value-addition or not and if the participant can contribute back to the organization or not.
- > Focus should be on role-plays, success stories and field-based training.
- The approach should not be one size fits all, rather a bottom-up approach is required.
- > Need for grassroot level training for members.
- Conducting proper general body meeting so that members have awareness about their cooperative.
- Example: push for renewal of societies in Telangana with a pre-requisite of member education.
- Contemporary challenges have to be dealt with and involvement of youth is essential to avoid the generational gap.

### Ms. Jabi Thapa, Registrar of Cooperative Societies, Sikkim



Ms. Jabi Thapa, gave an overview of the cooperatives in Sikkim and highlighted the following points:

- Over 4000 cooperative societies registered with coverage of 20% of households. In Sikkim, PACS are called MPCS and form the backbone of our cooperatives and our milk cooperatives are best examples of cooperatives.
- > Lack of awareness of cooperative sector at the grass-root level.
- > Absence of quality cooperative human resources.
- > Board members are generally not active.
- > It is perceived as a resource-starved concept based on government funding.
- > During COVID-19, cooperatives emerged as champions of the people.
- > In Sikkim, the first student cooperative is going to be registered.

# Ms. Valentina Arambam, Registrar of Cooperative Societies, Manipur



Ms. Valentina Arambam briefly introduced the two institutes that are catering to the needs of cooperative management in the North East, i.e., Institute of Cooperative Management (ICM) and the Centre of Cooperative Management (CCM) for training personnel in cooperative management from Manipur, Mizoram and Nagaland. She threw light on the following: -

- > In Manipur 25% of the people are covered by cooperatives.
- > ICM has a rich library and facilities and is very well established.
- > The CCM has an acute shortage of staff.
- > The CCM is in the process of completing recruitment to address its HR gap.
- > The CCM lacks in terms of infrastructure and manpower.
- In the meantime, considering the shortcoming, ICM and CCM should work in collaboration. CCM should coordinate with the ICM and can be used for training large numbers as it has infrastructure and hostel facilities.
- > Funding is also a major challenge for the cooperatives.
- Lastly, we need to work on synergy and convergence with line departments for awareness and sensitization with regards to cooperatives.

# Dr. Uddhaba Chandra Majhi, Registrar of Cooperative Societies, Odisha



Dr. Uddhaba Chandra Majhi presented his discussion by stating that in Odisha, the agriculture credit cooperative system is working in a well-computerized setup and leveraging the benefits of IT. The following were the key points that he discussed:

- Odisha State Cooperative Union, the apex institution of cooperative training has four centers and is offering diploma course and should be allowed to offer courses such as Higher Diploma in Cooperative Management and other management courses.
- Member awareness programs which were conducted by Cooperative Union can be carried out in partnership with agriculture and allied department.
- Most of the programs like crop loan under Kisan Credit Card, procurement of oilseed and pulses is being done through PACS and LAMPS.
- In distribution of agricultural inputs such as seeds, fertilizers and pesticides through MARKFED, etc., there is scope of convergence as each of the organizations is involved in Information, Education, and Communication.
- > Drawback of cooperatives is the lack of proper bookkeeping.
- > There is a need for standardized systems in such sectors like dairy, fisheries, etc.
- Lastly, he requested NCCT to offer guidance and ensure standardization of programs.

# Shri Anil Gawde, Registrar, Cooperatives Society, Maharashtra



Shri Anil Gawde highlighted that housing cooperatives form a major part of cooperatives. There are 14 training institutes in the state of Maharashtra. Large scale capacity building programs have to be conducted to make them efficient. There is inadequate access to training to members. Good quality training is the need of the hour. Rough survey says youth are not attracted to cooperatives, so to attract them transparency, employment opportunities and innovative initiatives have to be introduced. Awareness and advocacy of values of cooperatives is an important task. Gram Sabha also should have topics related to cooperatives. Merely imparting training will not yield results, there should be an impact analysis as well.

With this, the first segment of the webinar, featuring top-level officials from the cooperative department, came to an end.

The second segment of the webinar featured leaders from national level institutions that have an important role to play in the cooperative ecosystem.


### Shri T K Manoj Kumar, Chairman, Warehousing Development and Regulatory Authority, New Delhi



Shri T K Manoj Kumar introduced the Warehousing Development and Regulatory Authority which was established in 2010 and works in the agricultural space and registers and regulates warehouses. The following are his key observations:

- Almost 153 commodities have been identified for which scientific storage can be done.
- Warehouses in the country are not yet in good shape and the producers and the entire country pays a heavy price for this lack of infrastructure.
- If warehouses are improved and trained personnel are employed, significant savings will be realized, better incomes will be enabled, and huge employment opportunities will be created.
- WDRA offers training for warehouse managers, as a five-day program. WDRA is already working closely with NCCT to reach and train a large number of people in the cooperative fold.
- WDRA also organizes one-day farmer awareness programs for storing in registered warehouses.
- Warehousing is not just about storage; it is a holistic approach which brings wealth to the farmers.
- WDRA collaborates with different partner organisations to create large scale interest and employment.
- All trainings through WDRA are from central government grants hence funding is not a problem, rather the partner organisations are paid for conducting trainings.

Dr. S. Glory Swarupa, Director General, National Institute for Micro, Small and Medium Enterprises, Hyderabad



Dr. Glory gave the participants an overview of NIMSME and the different training programmes it offers, falling into four different categories – national executive development programmes, programmes for individuals, programmes for professionals, and programmes for MSMEs. Highlighting how the cooperative sector and MSME sector are closely interrelated, Dr. Glory highlighted different opportunities for synergy that can be realised through collaboration.



### Dr. M. Loganathan, Director I/C, NIFTEM- Thanjavur

Dr. M. Loganathan discussed the ODOP concept which is "One District, One Product" and how their master trainers develop trainers who are in turn delivering trainings at the grass-root level. On their portal, videos, ppts and DPRs are also available for making the process of education and training user-friendly. The focus is to develop entrepreneurs in the food sector, he added.

### Prof. (Dr.) S.O. Junare, Acting Vice Chancellor, National Forensic Sciences University, Gandhinagar



Prof. (Dr.) S.O. Junare, gave a bird's eye view of NFSU, highlighting examples where forensics plays a critical role. While doing so, he highlighted situations that are typical in the cooperative sector, to make the need amply clear. He stressed that only strong long-term collaboration can help in convergence for creating sensitization and strengthening the sector. He urged for a joint collaboration for providing consultancy services. He also discussed that the different type of stakeholders and training institutions can be updated and special training programs can be created for a holistic development.



### Shri Chandrasekhar Buddha, CCO, NEAT AICTE, New Delhi

Shri Chandrasekhar Buddha talked about the Skill India Initiative which touches millions of Indians and said that there is a huge opportunity in cooperative sector. The cooperative fold has more than 40 lac employees, which gives a large spectrum of people who can be supported in skilling, re-skilling and up-skilling. Involvement of youth is also very important as they will learn business models and understand better how to go about pathways such as entering the banking sector. Innovation has to be enhanced in the cooperative sector. He also spoke about the language translator tool. Internship opportunities will help in developing cooperative ethics.

## Valedictory Address by Dr. Umakant Dash, Director, IRMA



Dr. Umakant Dash concluded that many panelists have tried to highlight the gap in the demand and supply between training institutes and number of members that have to be trained. Almost one-third of the country is connected to the cooperatives. There are many existing institutes but there is need for synergy (which is seen in a limited sense) and a common platform (which we do not have yet) to bring everything together and make the whole ecosystem viable, vibrant, and capable of scale.

# Vote of Thanks by Mr. Sathiakumar Sam Michael, Deputy Director, NCCT

Mr. Michael offered vote of thanks and summarized the key points discussed by each speaker and delved deep into the how the cooperatives can be turned into an engine for development. He thanked the Secretary, Ministry of Cooperation and Shri Mohan Kumar Mishra, Secretary, National Council for Cooperative Training for creating this opportunity to take forward the very important mission of education and training in the cooperative sector, with insights coming from all the expert speakers. He wholeheartedly extended his regard for the participation of all the representatives of PACS, resource persons and all the dignitaries for such an insightful conversation in this national webinar.

### **Recommendations of the Webinar**

- The start-ups culture should be encouraged besides hand holding support and training on functional areas like, Marketing, Human Resources, Value Chain, Technology, Entrepreurship etc. for the relevance and fruitful engagements of the cooperatives and other form of collectives.
- 2. Standardization of training module should be planned at the state level.
- 3. Explore innovative ways to reach out people and provide them training.
- 4. Pedagogy, Mode of Delivery should be more creative.
- 5. Focus more on case studies, success stories and the best practices.
- 6. On the job training should be linked with promotion and Higher Diploma in Cooperative Management should be made mandatory minimum qualification for recruitments.
- 7. Member Education & Training programmes should be organized at the grass root level.
- 8. Convergence with State Cooperative Unions/Federation to achieve the scaling up of training at the grass root level.
- 9. The existing Cooperative Training Institutes should collaborate in conducting training programmes in the States to reach large members.
- 10. Training to all officials in the changing computerized environment like Core Banking Solution (CBS) and Common Accounting System (CAS).
- 11. In Order to attract the Youth, Women and Weaker Section, Promoting awareness and sensitization programmes be organized in which values of cooperatives, employment opportunities and innovative initiatives are to be included.
- 12. More awareness training programmes to be organized on warehouse management for the Farmer Members at the PACS level.
- 13. Under ODOP (One District One Product) focus should be to develop cooperative societies in the food sector.
- 14. Strong long term collaboration among training institutions can help in convergence for creating sensitization and strengthening the professionalization of functionaries & staff.
- 15. Innovation has to be enhanced in the cooperative sector.

- 16. Student internship opportunities in cooperatives will help in developing youth cooperative.
- 17. Promotion of online training, certificate programmes, short term programmes and designing and development of learning management system and mobile app by the NCCT for smooth running of various training programmes & activities.
- 18. Handholding by RICM Kalyani, ICM Guwahati and ICM Imphal to the District Unions and Junior Cooperative Training Centres in North East States on priority basis.
- 19. Promotion of student cooperatives and development of cooperative entrepreneurship at the school level to involve the youth at an early age to the cooperative movement.
- 20. Training to the PACS Members on usefulness of development of scientific storage godowns and warehousing receipts (NWR)
- 21. Strengthening of training infrastructure, computer labs, library, hostels etc. in cooperative training institutes through central and state assistance.
- 22. Need to promote research and innovations, consultancies and studies in the cooperative training institutions.
- 23. Promotion of various courses for skill development and entrepreurship in rural areas through cooperative training institutes.
