Non receipt of factual information from training institute creates a large number of difficulties in planning recruitment, MACP, Promotion, transfer posting etc. by NCCT (HQ).

All institutes of NCCT are requested to ensure the timely submission of quarterly return in the prescribed proforma (Copies enclosed) duly completed in all respect, latest by 5th of following month for which return relates. Directors of the concerned institute shall ensure submission of the requisite return in time.
